Settlements will not be withheld on account of any question as to the correctness of charges which cannot be immediately adjusted, or for alleged overcharges, or any accounts that may be claimed to be due from the Railroad Company: but in such cases a claim will be filed for refund of charges believed to be in excess of the lawful amount due.

This credit agreement shall be deemed to have been made in Berks County, Pennsylvania and the undersigned, as part of the consideration for this Credit Agreement, consents to the jurisdiction of any court of record of the Commonwealth of Pennsylvania and the United States District Court for the Eastern District of Pennsylvania with respect to any proceeding arising out of this agreement and further, if necessary, agrees that the mailing of any process shall constitute lawful valid process.

The undersigned shall be responsible for all collection costs and attorney's fees in connection with any delinquent amount. **An incomplete application will delay the processing.**
